2. Composition E-glass yarn with main chemical content SiO₂ ~ 54 %; Al₂O₃ ~ 14 %, CaO + Na₂O ~ 22 %,

3. Hazards identification

Influence on the people From AVKOPACK 1502 are not separated vapour. Separated from the packing glass fibers can cause slight irritating, itching or breath problems for people with allergy. Do not touch eyes with dirty hands.
